Every person appointed to act as an enumerator, or in any other capacity under this Act, and every other person who is bound under this Act, if required, to act as an enumerator, making wilful default in any of the matters required of them respectively by this Act, or making any wilfully false declaration, shall for every such wilful default or false declaration be liable on conviction to a penalty.
