Reminder

After completion, the control schedule shall be sent promptly to the Council in which the person concerned is to be counted. The Council shall promptly pass it on to the controller, who shall verify, in consultation with the enumerator and census officer, that the person concerned has been entered on the enumeration schedule. If he has not been counted, the data from the control schedule shall be recorded on the enumeration schedule. The control schedule shall be attached to the enumeration schedule in all cases.

Ques. 1— Household Number

Mark the same number as shown on the Visitation Record for this household. Mark the same household number for each person in the household.

Ques. 4— Relationship to Head of Household

Mark only one box for each person to indicate the relationship, e.g., head, wife, daughter, son-in-law, mother, employee, lodger's wife, inmate. If the appropriate relationship is not listed, e.g., uncle, aunt, cousin, write it in the space provided.

Ques. 6— Age at Last Birthday

Mark one box in each column, e.g., if less than 10 years, mark 0-1 for one year, 0-2 for 2 years, 0-3 for 3 years, etc.

Ques. 8— Does This Person Live On a Farm?

Mark "Yes" for all persons residing in a dwelling located on a farm.
